Eligibility		Residential customers in the distributor area must have the <b>Minimum solar PV capacity</b> and <b>Minimum sonnenBatterie useable capacity</b> for the relevant sonnenFlat plan.			
Adjusted Annual Usage Allowance		Each household must produce the <b>Minimum Annual Generation</b> quantity of energy over a 12-month period. Where the annual energy production falls below the <b>Minimum Annual Generation</b> , the <b>Annual Usage Allowance</b> will be reduced proportionally to the shortfall in the <b>Minimum Annual Generation</b> . e.g.: For <b>sonnenFlat Economy</b> , if actual annual solar production is 6,000 kWh, then the <b>Adjusted Annual Usage Allowance</b> is => 6,500 x 6,000 / 6,515 = 5,986 kWh.			
Excess Usage Rate		Once the <b>Adjusted Annual Usage Allowance</b> is exceeded, subsequent <i>usage from the grid</i> will be charged at the <b>Excess Usage Rate</b> .			
Solar feed-in Rate		Energy exported above the <b>Annual Export Threshold</b> will be paid at the <b>Solar feed-in Rate</b> .			
Early termination		<b>Annual Usage Allowance</b> and <b>Minimum Annual Generation</b> will be reduced pro-rata where a customer ends the agreement within a 12-month period.			

Metering	Measurements from sonnenBatterie meters and regulated NMI meters will be used to determine <b>Annual Usage Allowance</b> and <b>Minimum Annual Generation</b> . Measurements from NMI meters will be used to determine <b>exported energy</b> and <b>excess grid usage</b> . Regulated NMI meters must be interval meters.
Battery Operations	sonnen may operate the sonnenBatterie remotely at its sole discretion.
<b>Fees</b>	
Meter installation fee	Fixed rate - \$207.90 A \$ 207.90 (incl GST) fee will be charged for a Type 4 meter installation, if required.
Exit fee	Fixed rate - \$0.00 We don't charge customers exit fees.
Late payment fee	Fixed rate - \$16.00 A \$16.00 (incl GST) fee applies for each bill that is paid after the due date.
Direct debit dishonour fee	Fixed rate - \$11.00 A \$11.00 (incl. GST) fee applies if payment is dishonoured or reversed.
